

Proceedings before the Hon. Jos. G. Huffman one of the Judges in and for the First Subdivision of the Seventh Judicial District of Ohio, began and held at the Court House in the Town of Logan and County of Hocking on the 7th day of January A.D. 1895.

Be it remembered that heretofore, to-wit: On the 27th day of Nov. A.D. 1894, came Seth Weldy, Petitioner and filed in the office of the clerk of the Court of Common Pleas, in the following entitled cause which is as follows:

In action to vacate, Lots, Streets and Alleys as an Addition to the Town of Logan, Ohio.

Petition: To the Hon. Court of Common Pleas of Hocking Co., O., ex parte,

The undersigned represents that he is the sole owner in fee of the following described real estate, to-wit: Out-lots Nos. 173, 174 and 175, in Northington's Addition to the Town of Logan; and Fractional Lots Nos. 1 and 13, containing about eleven and one-half acres, in Section No. 11, Township No. 14, Range No. 17; also Fractional Lot No. 9, in Sec. No. 10, Township No. 14, Range No. 17, containing about two acres, containing in all eighteen acres of land more or less, and for a more particular description of which reference is hereby made to the Recorded Plat of said Lots and Parcels of Land, in the Recorder's office of Hocking County, Ohio. All of the above described real estate being situated in the County of Hocking and State of Ohio. That heretofore one George W. Alfred caused the aforesaid real estate to be platted and laid out in lots, avenues, streets and alleys, as an addition to the Village of Logan. And the same was accepted by the Council of said Village as such addition, which was designated as Alfred's Addition to the town of Logan, Ohio, a plat of which is hereto attached, marked "Exhibit A" and made a part of this proceeding.

The undersigned further represents that since said addition was platted and accepted by said Village Council as an addition thereto, the Hocking Canal which runs through said addition on the north side thereof has been abandoned, and a railroad is in process of being built through the same, by reason of which the lots, avenues, streets and alleys, as laid out, do not properly conform to the change made by reason of the abandonment of said canal and the building of said railroad.

Wherefore the undersigned, as the owner of the aforesaid real estate, prays that the whole of said addition with the streets, avenues and alleys, may be vacated as an addition to said town of Logan, Ohio.
