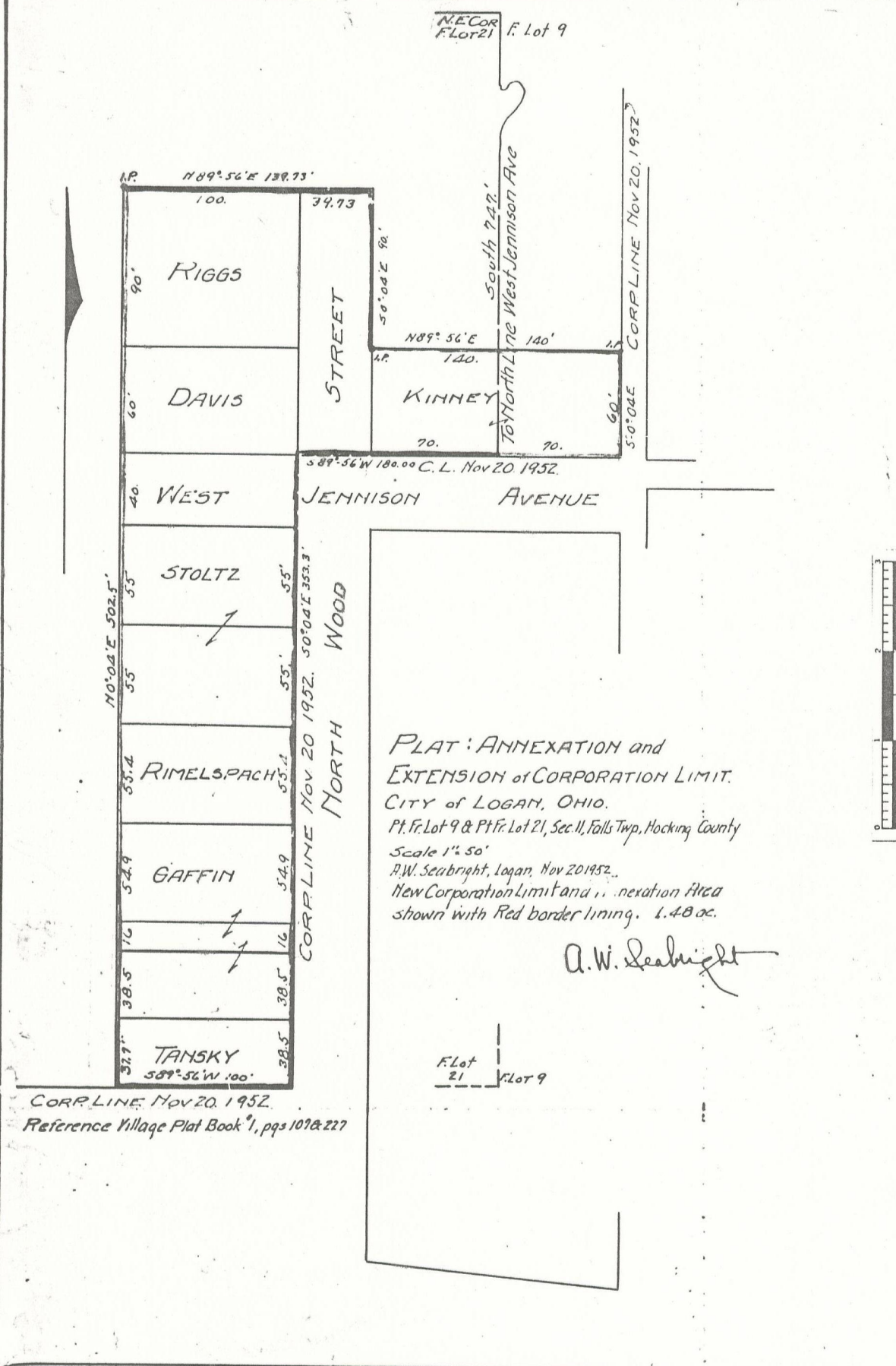
LEGAL NOTICE Notice is hereby given that on the 28th day of November, 1952, there was presented to the Board of Commissioners of the County of Hocking, State of Ohio, a petition signed by a majority of the adult free holders residing in the following described territory situated in the County of Hocking and adjacent to the City of Logan, Ohio to wit:
