And the said David Hand for and in consideration of One dollar paid by the said Incorporated Village of Logan do hereby give to said Incorporated Village of Logan so much of Lot No 153, as consecutively numbered, as may be necessary to make Culver's Street 100 links wide at that point and as the same is shown on the plat, and I do hereby dedicate the same to public use as and for a street, and for no other purpose whatever.
