

In the Matter of The Annexation of
Certain Territory to the City of
Logan, Ohio, Petitioned for by
J.P. Canty, et. al

Order of Commissioners for Annexation
Dated August 12th 1921

The commissioners of the County of Hocking, State of Ohio proceeding this day to
hear the petition of P. J. Canty, et. al. to obtain the annexation of the territory in their petition
described to the City of Logan Hocking County Ohio and having in open meeting heard all the
persons desiring to be heard for or against the granting of said petition and having considered
all the evidence offered in respect thereof and being fully advised in the premises, find
that said petition contains all the matters required by law; that its statements are true;
that the territory sought to be annexed is adjacent to said city of Logan, Ohio; that the
petition contains a full description of said territory; that the map of said territory attached
to the petition is accurate; that said petition is signed by a majority of the adult freeholders
residing on the territory sought to be annexed; that the required legal notice of the
petition has been granted and that it is right and proper that said petition should be
granted. It is hereby ordered that the prayer of said petition be granted; that the
territory described in said petition may be annexed to the city of Logan, Ohio, in
accordance with law and that a certified transcript signed by a majority of this Board
of all the orders and proceedings of this Board relative to said petition and hearing thereon
together with said petition and map attached thereto and all the papers on file relating to
said matter be deposited forthwith with the Clerk, (Auditor), of said City.

Motion of Mr Smith, seconded by Mr Ulrick that said resolution be adopted.

An Ordinance

Accepting the application of P. J. Canty et. al. for the annexation of Territory to the
City of Logan Ohio.

Be it ordained by the Council of the City of Logan, State of Ohio:

Sec 1. That the application of P. J. Canty et. al. for the annexation of the following described
territory in the county of Hocking and adjacent to the city of Logan Ohio, to wit:
Being a part of Fractional Lots Nos 9 and 21 of section No. 11 T. 14 N. R. 17 W. Hocking county Ohio.
Beginning at a point on the west boundary line of Cherry Avenue and 273.1 ft north of the
north east corner of lot No 974 at now laid out and in the present north corporation line
of the City of Logan Ohio; Thence, with said corporation boundary line S 88° 47' W. 1270 ft
to a point in the west boundary line of north Wood Strat, Thence with the west line of said
Street N. 0° 04' W. 353.6 ft.; Thence with the north boundary line of West Junison Avenue as
shown on the plat hereof and attached hereto, N. 89° 56' E. 180 ft to a point in the east line of
F. P. Martins lands and in the west line of Glenview Heights Addition, Thence with said line
N. 0° 04' W. 615.9 ft. Thence, with the boundary lines of Glenview Heights Addition, N 89° 56' E. 304.8 ft
Thence S. 37° 21' E. 767 ft. Thence S. 54° 28' E. 215.5 ft. Thence East 148.5 ft. to a point in the
west boundary line of Cherry Avenue, Thence, with said line, S 0° 43' N. 209.2 ft to the place of
beginning, containing 17 acres. An accurate map of which territory together with the petition
for annexation and other papers relating thereto and a certified transcript of the proceeding of the
County Commissioners relating thereto are on file with the clerk of said City, be and the same is
hereby accepted.

Sec 2. This ordinance shall take effect and be in force from and after the earliest
period allowed by law.
