Notice is hereby given that on the second day of September 1872 the Corporate Authorities of the Village of Logan filed with the Board of Commissioners in and for the County of Hocking and State of Ohio a petition setting forth that under an ordinance duly and legally passed for that purpose by the Council of the said Village the territory therein described was duly authorized to be annexed to said corporation it being contiguous thereto and described as follows; viz: Being so much of the County of Hocking and State of Ohio as is enclosed in the following lines.
