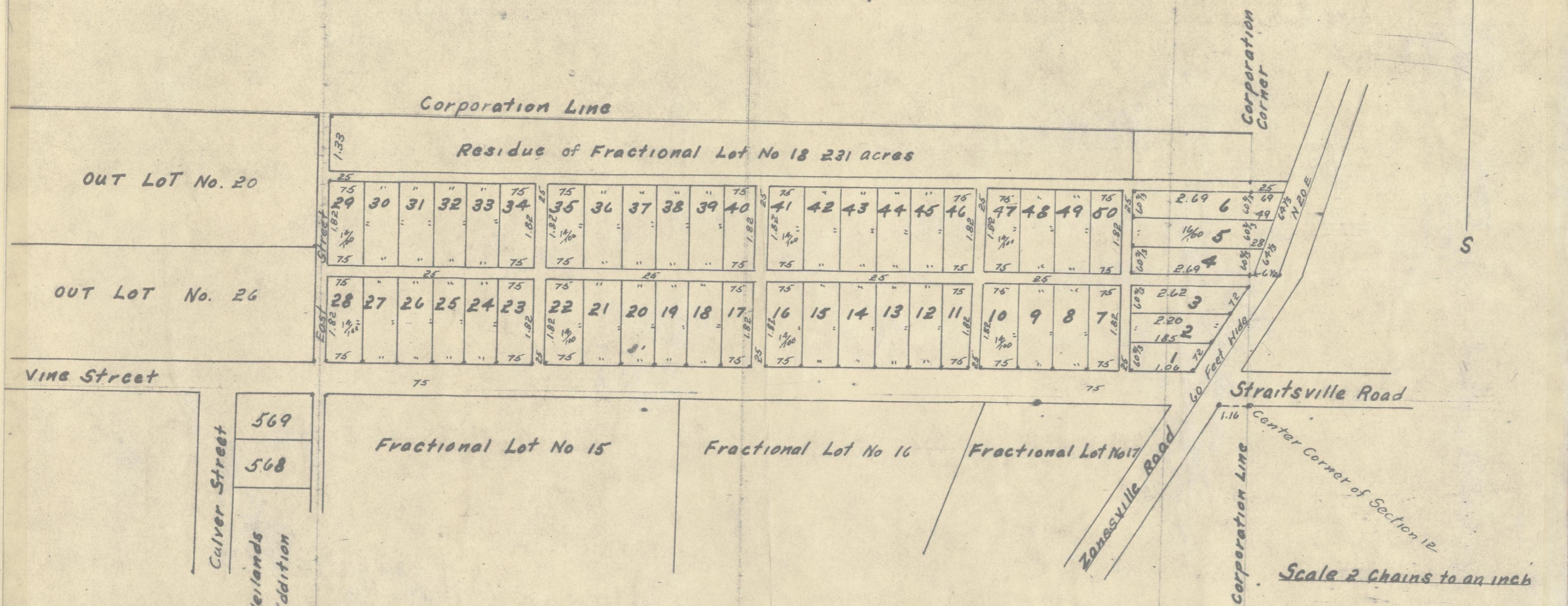

 APPLICATION TO VACATE PART OF VINA WRIGHT'S SUBDIVISION OF FRACTIONAL LOT 18.

Applicants, Margaret Price and Gladys B. Lanning, are the proprietors of the following described Lots in Vina Wright's Subdivision of the City of Logan, Ohio, as shown by the recorded Plat on file in the Office of the Recorder of Hocking County, Ohio, and therefore represents to the Court that they consist of more than two-thirds of the proprietors of the lands described in the portion of said plat, marked "Exhibit 'A'" and made a part of the application, as indicated on said plat.

Applicants state that said subdivision was properly laid out and dedicated as shown by the recorded plat thereof, and further state that the streets and alleys situated within that part of said subdivision now sought to be vacated and returned to acreage, are not in general use by the public, and never have been actually laid out and dedicated, or improved, and that there is now no traffic over any of said streets or alleys or is any actual use now being made of said streets or alleys, in the portion of said subdivision which applicants now seek to have vacated.

Applicants therefore Petition this Court to alter and vacate said plat of said Vina Wright's subdivision to said City of Logan, Ohio, so far as the same plats and dedicates the lots hereinafter described.

Applicants represent that the portion of the plat of said Vina Wright's subdivision which they are now petitioning to have vacated and altered is described as follows:

Being a part of Fractional Lot No. 18, Section 12, Township No. 14, Range No. 17, Hocking County, Ohio, platted as Lot Nos. 11 to 46, both inclusive, of Vina Wright's subdivision of said Fractional Lot No. 18, as shown by plat book "B", Page 21, Plats of Sections, Office of Recorder, Hocking County, Ohio, together with all alleys in said Vina Wright's subdivision West of a line North from Vine Street to the North line of said subdivision along the East lot lines of Lots 11 and 46.

Wherefore applicants pray that the plat of Lots numbers 11 to 46 both inclusive together with the streets and alleys heretofore dedicated and abutting and adjacent to said lots as platted upon said Vina Wright's subdivision, be vacated, and hereafter known and recognized as part of Fractional Lot 18, Section 12, Township 14, Range 14, of the City of Logan, Ohio, as though the same had never been platted as a part of Vina Wright's subdivision and for such other and further relief as is just and equitable.
