Basis of Bearings: The bearings shown hereon are based on GPS observations using the Ohio Department of Transportation CORS Network.

Ohio State Plane (South Zone) Grid Coordinates were collected for the following points: 10, 11, 14, 15, 20, 21, 22, 23, 26, 37, 38, 47, 100, 101, 102, 127, 304, 305, 309 and 310. All GPS traverse points were observed on two occasions, and average grid coordinates were calculated. These grid coordinates were converted to ground coordinates by applying a scale factor of 0.9999434. This scale factor was calculated by taking the average scale factor from NGS Monuments "Tabor" (scale factor = 0.9999439).
