

Being a part of the tract of land in the name of Marcella and Floyd Hiles as recorded in Deed Book 184 at page 219, Hocking County Recorder's Office, said tract being a part of Lot 6 in the "Hillcrest Allotment" recorded in Plat Book "D" at page 42 said allotment being situated in Fractional Lot 1 in Section 14, T14N, R17W, Falls Township, Hocking County, State of Ohio, and more particularly described as follows:

Beginning at a point being the northeast corner of Lot 6 in the "Hillcrest Allotment" from which a 2" iron pin found bears North 10 degrees 02 minutes 30 seconds West a distance of 15.706 feet;

Thence along the east line of Lot 6 the following three courses:

- [1] South 10 degrees 02 minutes 30 seconds East a distance of 176.458 feet to a 2" iron pin found,
- [2] South 16 degrees 29 minutes 15 seconds East a distance of 127.977 feet to a 2" iron pin found, and
- [3] South 25 degrees 10 minutes 47 seconds East a distance of 88.04 feet to an axle found on the northeast corner of Lot 7 in the "Carl Mock Subdivision" recorded in Plat Book "C" at page 35;

Thence along the south line of Lot 6 in the "Hillcrest Allotment", South 86 degrees 51 minutes 39 seconds West a distance of 60.137 feet to a 3/4" iron pipe found on the easterly right of way line of Summit Drive;

Thence along the right of way line of Summit Drive the following two courses: [1] North 23 degrees 12 minutes 30 seconds West a distance of 320.386 feet to a point, and


[2] North 42 degrees 16 minutes 30 seconds West a distance of 7.882 feet to a 5/8" iron pin with a plastic identification cap set on the north line of Lot 6 in the "Hillcrest Allotment";

Thence leaving the right of way of Summit Drive and along the north line of said Lot 6, North 47 degrees 43 minutes 30 seconds East, passing through a 1 1/2" iron pin set in concrete found at 110.00 feet, going a total distance of 117.658 feet to the place of beginning, containing 0.5781 acre, more or less, subject to all easements of record.







DESCRIPTION OF SURVEY FOR MR. & MRS. JOSEPH LEWIS

Being a part of a tract of land described in Vol. 435, Pg. 001, Hocking County Official Records, said tract being part of Lot No. 7 of the "Amended Hillcrest Allotment", as delineated in Plat Cabinet 1, Pg 87B, situated in Fractional Lot No. 1 of Section 14, Falls Township, T14N, R-17W, Hocking County, Ohio, and being more particularly described as follows:

Beginning at a 5/8 inch iron pin found on the southeasterly corner of the 0.32 acre tract described in O.R. Vol. 471, Pg. 832;

Thence with new lines the following two(2) courses:

- 1) South 24°46'22" East, a distance of 24.43 feet to an iron pin set;
- 2) South 40°51'18" West, a distance of 103.19 feet to an iron pin set On the westerly line of said Lot No. 7;

Thence, with said westerly line, North 36°30'30" West, a distance of 36.15 feet to a 5/8 inch iron pin found on the southerly-most corner of the previously cited 0.32 Ac tract;

Thence, with the southerly line of said tract, North 47°54'00" East, a distance of 106.16 feet to the place of beginning, containing **0.0702 acre**, more or less, and being subject to all valid easements.

Cited bearings are based on the north line of Lot No. 7 of the "Amended Hillcrest Allotment", as running North 47°54'00" East.

All pins described as being set are 5/8 inch by 30 inches long with a 1-1/4 inch plastic I.D. cap stamped "M.P.B. S-6803".
