#### SURVEY REPORT

In August of 2008 I was retained to locate the west property line of the tracts of land in the name of Christopher and Bona Patzkowsky in Section 19 Marion Township. There were trees damaged due to a lightning storm and we were to determine their location with respect to the property line.

In the process of establishing the west line, using the survey by Dumond, Sifford & Associates dated 8-28-69, I could not locate the pin at the northwest corner or the pin at 24.55 feet off the center of the road. I found a pin at the southern most corner in the center of the road. I discovered when using the center of the road and using the record angle at the southern most corner I was following an old fence line and missing the southwest corner of the garage by some 3 feet. I determined that given the way some property was surveyed in 1969 and early 70's that the old fence line was accepted as the property line and a deed was prepared from that s vey. At a later time two more tracts were created by Dumond, Sifford & Associates using this first field survey. It is appearant that the latter surveys were just prepared in the office and not by an actual field survey. No monuments were set.

In 1992 a survey was conducted by Larry Gerstner for The First Community Church of Columbus. His survey line started at the same point in the road but he ran the line 1 degree 5 minutes east of the old fence line. This would make a wedge of land between his line and the old fence line starting at 0 feet at the road and 14 feet, more or less, at the northwest corner of the southeast quarter of the northeast quarter by the Gerstner survey. His survey line is into the garage by three feet. I would suggest that at a minimun the 0.0831 acre tract as shown on this plat should be quite claimed to the Patzkowskys to clear up the title.
