## **COMMISSIONERS MEETING JANUARY 27, 2009**

The Board of Hocking County Commissioners met in regular session this 27<sup>th</sup> day of January 2009 with the following members present Sandy Ogle, Greg Green and John Walker.

**MEETING:** The meeting was called to order by President John Walker.

**<u>MINUTES</u>**: Motion by Greg Green and seconded by Sandy Ogle to accept the minutes. Vote: Ogle, yea, Green, yea, Walker, yea.
