SANDY JOHNSON-HAPCAP: Sandy Johnson with Hocking Athens Perry Community Action spoke with the Commissioners about the stimulus package and told them in order to apply for funding for projects, to go to www.recovery.ohio.gov. She also spoke to the Commissioners about the Haydenville sidewalk project. The sidewalk was originally proposed to be constructed in front of several homes, which was a concern to these residents because the sidewalk would impede parking. It was suggested that the sidewalk be constructed on the other side of the road. Sandy explained that they just received the engineer's opinion, and he recommends the sidewalk be constructed on the canal side. He said this would be a safer solution because on the other side, on average there is only 13 feet which he suggested at least 16 feet to allow for car doors to be open on either side without obstructing the road or sidewalk. If the sidewalk were constructed on the canal side, it would also offer a clearer line of sight. Sandy added that Larry Horn and some others were concerned about the sidewalk being constructed on the canal side because they felt the dirt was not stable. Sandy said that County Engineer Bill Shaw, County Planner Audie Wykle and the project engineer all felt that was not an issue.

CATHY HILL-CHILDREN SERVICES: Cathy Hill, Director of Children Services, wanted to acknowledge Auditor Ken Wilson and Susan Robinette in the Auditor's office for getting some necessary checks out during the power outage/ice storm. She also spoke with the Commissioners about interns driving the agency vehicles. They told her that Mr. Kinder is preparing a response and they will pass that along as soon as it is received. The Commissioners gave Cathy waivers that volunteers and interns should sign acknowledging no compensation if injured.

RECONVENE BENSONHAVER ROAD HEARING: The Bensonhaver Road Hearing was reconvened at 11:00 am. John gave a recap that the decision was delayed at the request of the Ohio Department of Natural Resources, in which they said they would have an opinion sent by the close of business on Friday. The Commissioners office has yet to receive any word from ODNR. John called several times and did end up speaking with someone who said they still have not come up an answer.

<u>VACATE PORTION OF BENSONHAVER ROAD:</u> Motion by Greg Green and seconded by Sandy Ogle to vacate the proposed portion of Bensonhaver Road, upon the recommendation of the Trustees and to allow for a utility easement. Vote: Ogle, yea, Green, yea, Walker, yea.

DISCUSSION OF ROAD VACATION: Greg clarified that he wanted the utility easement because of the possibility of Broadband, they may need that area for a tower or for any other utilities. Bill Kaeppner explained that if the Commissioners ever want to reopen that road, then they will have to buy it back from the land owners. He said that because the letter was never sent to ODNR that the hearing never should have continued. He added that the OMTA would mark roads like this and put up signs, and that it doesn't cost the land owner to keep the road open. He concluded that he feels this was a bad decision. Terry Dicken, on behalf of Bolton Farms, said that he understood what Bill was saying, but it does cost the landowner when someone trespasses and is injured. Larry Dicken, Washington Township Trustee added that there is no state ground in Washington Township and that the Township has nothing to do with the utility easement.
