He added that there are no cases in Hocking County at this time and if anyone has questions, they should reference the CDC website.

SHERIFF LANNY NORTH-NARCOTICS K-9: Sheriff Lanny North spoke to the Commissioners about a K-9 that will be used for Narcotics only that Matt May has purchased and trained on his own. He will continue to care for the K-9, the county will just need to provide liability coverage which is \$250 per year.

<u>AGREEMENT-NARCOTICS K-9</u>: Motion by Greg Green and seconded by John Walker to approve the Agreement with Matt May, effective immediately through December 31, 2010, for the Narcotics K-9 to be cared for by Matt May with the County only being responsible to provide liability coverage. Vote: Green, yea, Walker, yea.

<u>APPLICATION FOR APPROVAL OF UNDERGROUND CONSTRUCTION</u>: Motion by Greg Green and seconded by John Walker to approve the Application for Approval of Underground Construction on Hocking County Right-of-Way for AEP to install Overhead/underground primary line extension on Twp Rd. 227 Topping Road to 15001 Topping Road. Vote: Green, yea, Walker, yea.

PUBLIC HEARING-SALT BRINE-HOCKING HILLS CANOPY TOURS: A public hearing was held at 10:00 am for the application of salt brine for Hocking Hills Canopy Tours. Greg mentioned for the record that the guidelines for applying salt brine are established by the EPA. Ralph Stobbs of Davis Chapel Road spoke to the Commissioners about his many attempts to get salt brine to treat his road. He said the EPA and his Trustees said no. He feels that if this application is granted, they he should get it as well The Commissioners explained that the Trustees have permission to apply yearly and would provide him with the supporting paperwork. There was no other public comment.

<u>ACTION ON APPLICATION OF SALT BRINE – HOCKING HILLS CANOPY TOURS</u>: Motion by Greg Green and seconded by John Walker to grant the request of Hocking Hills Canopy Tours, 10714 Jackson Street Rockbridge, Ohio to apply salt brine to their driveway and selected portions of access trails for purposes of dust control. Vote: Green, yea, Walker, yea.

<u>AFLAC</u>: Representatives from AFLAC spoke to the Commissioners about the possibility of adding AFLAC to their employee benefit package, which would be voluntary for employees at no cost to the county. The Commissioners and Auditor will review the information.
