911 MONTHLY REPORT: Motion by Sandy Ogle and seconded by Greg Green to approve the 911 Monthly report for May 2009. Vote: Ogle, yea, Green, yea, Walker, yea.

APPLICATION FOR APPROVAL OF UNDERGROUND CONSTRUCTION ON HOCKING COUNTY RIGHT OF WAY: Motion by Greg Green and seconded by Sandy Ogle to approve the Application for Approval of Underground Construction on Hocking Count Right of Way for Todd Baker to Bore a water line from 34310 Moore Road to barn located at the same location. Vote: Ogle, yea, Green, yea, Walker, yea.

SANDY JOHNSON -HAP COMMUNITY ACTION-2009 CDBG REQUESTS FOR FUNDING: Sandy Johnson with HAP Community Action spoke to the Commissioners about the 2009 CDBG Requests for Funding. There was one complete submission, which was Murray City Street Improvements and two submissions that would need further verification for eligibility.

2009 CDBG PROJECT SELECTION: Motion by Greg Green and seconded by Sandy Ogle to include the Murray City Street Improvements project request for consideration for the 2009 CDBG Grant. Vote: Ogle, yea, Green, yea, Walker, yea.

SANDY JOHNSON-HAP COMMUNITY ACTION: Sandy Johnson with HAP Community Action spoke to the Commissioners about \$45,000 left over from the 2008 CDBG Formula money. She said that the application could be amended to add another activity. Greg asked if it could be used for the brickyard. Sandy said she would have to look at it, but it would have to meet all of the eligibility requirements and it would have to be used to complete a phase, which that amount of money would not do. The Commissioners asked Sandy to check to see if the Murray City storm drainage issue would be able to be completed in the time frame. Sandy also spoke to the Commissioners about the 2007 CDBG Haydenville sidewalk project. She explained that there is one resident that will need excavation done to the yard due to the property elevation.

BILL ACTION: Motion by Sandy Ogle and seconded by Greg Green to approve the county bills and Then & Now purchase orders dated June 5, 2009 totaling \$178,410.58 and the EMS bills dated May 16-31, 2009 totaling \$2,291.11. Vote: Ogle, yea, Green, yea, Walker, yea.

COURTHOUSE DIRECTORY: Sandy said that a new courthouse directory will not be feasible at this time due to the budget.

SUE RAUBER, EMA DIRECTOR: EMA Director Sue Rauber spoke to the Commissioners about a new cell phone. The state recommended that she purchase either a Blackberry or an iphone, which she has chosen the iphone, due to recommendation from other Directors. She explained that she will be able to receive emails while out in the field. She also clarified that she has the funds in her budget to purchase the phone and for the monthly service costs.
