EMA COUNTYWIDE AGREEMENTS-VILLAGE OF LAURELVILLE, STARR AND WARD TOWNSHIPS: Motion by Sandy Ogle and seconded by John Walker to approve the EMA Countywide Agreements for the Village of Laurelville, Starr and Ward Townships. Vote: Walker, yea. Ogle, yea, Green, yea.

RECESS: The meeting recessed at 10:12 am.

RECONVENE: The meeting reconvened at 10:25 am

AUDITOR KEN WILSON: Auditor Ken Wilson gave the Commissioners the end of year report for 2009.

EXECUTIVE SESSION: Motion by John Walker and seconded by Sandy Ogle to enter into Executive Session at 10:39 am to discuss personnel. Vote: Walker, yea, Ogle, yea, Green, yea.

EXIT EXECUTIVE SESSION: Motion by John Walker and seconded by Sandy Ogle to exit Executive Session at 11:45, no action taken. Vote: Walker, yea, Ogle, yea, Green, yea.

RECESS: Motion by Sandy Ogle and seconded by John Walker to recess the meeting at 11:45 am until 2:00 pm. Vote: Walker, yea, Ogle, yea, Green, yea.

RECONVENE: The meeting reconvened at 2:00 pm in the EMA Conference Room with General Fund Department Heads.

GENERAL FUND DISCUSSION: Greg began the meeting by saying that everyone was faced with difficult decisions concerning the budget cuts and it is very easy to say yes, but difficult to say no. He continued to say that if everyone continues to keep their spending down that would help and to please offer any suggestions that may save money. Sandy said that she doesn't want the county to get into a situation of a fiscal watch. John agreed and thanked everyone and said he hoped that we do as well in 2010 as we did in 2009. Auditor Ken Wilson proceeded to give the 2009 end of year report. He explained that for 2009 the county was in deficit spending by \$132,273, for 2010 it is projected that the county will be in deficit spending by \$485,892, which will bring the carryover balance to \$1,606,358. He continued to say that in order to balance the budget for 2010, the general fund expenditures would have to be cut an additional 7.55%. Ken asked if how everyone would like to proceed with the meetings, if they would like monthly meetings or quarterly. Treasurer Diane Sargent said she feels that quarterly meetings would be best until more revenue figures come in and they find it necessary. The next meeting was set up for April 22nd at 2:00 in the EMA Conference Room. Resident Mike Nihiser asked Ken when the new real estate evaluations will affect the budget. Ken said they would in 2011.

ADJOURNMENT: Motion by John Walker and seconded by Sandy Ogle to adjourn the meeting. Vote: Walker, yea, Ogle, yea, Green, yea.
