AUTHORIZE TO CAMERA ROCKBRIDGE SEWER LINES: Motion by John Walker and seconded by Sandy Ogle to authorize the Sewer Department to camera the Rockbridge Sewer lines and have Dreier & Maller, Inc. to perform the work. Vote: Walker, yea, Ogle, yea, Green, yea.

TRAVEL: The following travel was read into The Record:

LOAD LIMIT REDUCTION-COUNTY ROADS: Motion by Sandy Ogle and seconded by John Walker to reduce the legal load limit by 50% on All county roads, except CR#33A, Chieftain Drive, CR #33B, Hocking Drive and CR #25, Haydenville Road, effective February 1, 2010 through April 30, 2010. Vote: Walker, yea, Ogle, yea, Green, yea.

ADDITIONAL APPROPRIATIONS: Motion by Sandy Ogle and seconded by John Walker to approve the following Additional Appropriations:

- 3) Certificate of Title - \$1,800.00 in D51-07/Transfers

BUCKEYE JOINT COUNTY INSURANCE-LEGAL INVOICES: Greg mentioned that there are two invoices from Buckeye Joint County Insurance for legal services for the Sheriff's Office. Greg noted that the Sheriff could pay this out his contract services, but will need the money later in the year.

SEWER DISCUSSION: The Commissioners discussed the Sewer and what they can do for the delinquent accounts. They discussed the possibility of contracting with Le-ax and Old Straitsville Water for the areas they cover, to shut off the water if the sewer bill isn't paid. For the areas that do not have water, they will have to see how much it will cost to shut off the sewer.

CHILDREN SERVICES DIRECTOR CATHY HILL AND J&FS DIRECTOR BOB SMITH-CHILD, FAMILY AND ADULT COMMUNITY AND PROTECTIVE SERVICES: Children Services Director Cathy Hill and Job & Family Services Director Bob Smith spoke to the Commissioners about the Child, Family and Adult Community And Protective Services allocation that Job & Family Services received in the amount of \$46,901.99 from the state. Bob said that he feels that Children Services needs this money and could best utilize it. He asked that the Commissioners approve a transfer of the funds.

AUTHORIZE TRANSFER OF CHILD, FAMILY AND ADULT COMMUNITY AND PROTECTIVE SERVICES FUNDS FROM J&FS TO CHILDREN SERVICES: Motion by John Walker and seconded by Sandy Ogle to authorize the Transfer of Child, Family and Adult Community and Protective Services funds from Job & Family Services to Children Services. Vote: Walker, yea, Ogle, yea, Green, yea.

EXECUTIVE SESSION: Motion by John Walker and seconded by Sandy Ogle to enter into Executive Session at 10:38 am with Dog Warden Don Kiger to discuss personnel. Vote: Walker, yea, Ogle, yea, Green, yea.

EXIT EXECUTIVE SESSION: Motion by Sandy Ogle and seconded by John Walker to exit Executive Session at 11:18 am, no action taken. Vote: Walker, yea, Ogle, yea, Green, yea.
