AMENDMENT TO SUBGRANT AGREEMENT-J&FS AND CHILDREN SERVICES: Motion by John Walker and seconded by Sandy Ogle to approve the Amendment to Subgrant Agreement between Hocking County Department of Job & Family Services and Hocking County Children Services for Title XX-TANF Transfer with Paragraph 3, Availability of Funds is amended by increasing the total dollar value of this contract by \$25,000, for a total of \$125,000, retroactive to August 27, 2009. FOR THE RECORD: The Commissioners received the 2009 Annual Report from Judge Wallace for Municipal Court.

FOR THE RECORD: Sandy noted that she spoke with Audie concerning the easement for AEP for Smith Chapel Food Pantry. They still do not have the proper documentation to describe the location, Audie will call AEP.

PROSECUTOR'S HOT WATER TANK: The Commissioners discussed the possibility of purchasing a new hot water tank for the Prosecutor's Office. John noted that he is not in favor of purchasing the hot water tank and would prefer purchasing hand sanitizer for them.

PURCHASE HOT WATER TANK FOR PROSECUTOR'S OFFICE: Motion by Sandy Ogle and seconded by Greg Green to purchase a 6 gallon electric hot water tank for the Prosecutor's Office. Vote: Walker, no, Ogle, yea, Green, yea.

SEWER DEPARTMENT-TROUBLE ACCESSING COMMUNITY SERVICE WORKERS: Sewer Superintendent Kevin Loudin explained to the Commissioners that he is having difficulty accessing Community Services workers for the summer. The Commissioners said they would speak with the Judge.

JUDGE WALLACE: The Commissioners spoke with Judge Wallace about the availability of Community Services Workers and explained that the Sewer Department has had difficulty accessing them. Judge Wallace said he would look into it.
