Greg began by expressing his gratitude to the department heads for streamlining their budgets and making the difficult decisions when cutting the budget. Treasurer Diane Sargent gave an update on the revenue side of the budget. She said that we are still showing a loss every quarter, but some longer term investments interest rates are rising. She said things are looking a little better, but still taking a loss. She continued to say that the Real Estate Settlements had a better response the last year. Auditor Ken Wilson gave an overview on the revenue for the first quarter, saying that we are as good as projected, maybe a little better. He also gave a brief update on expenditures by department. Ken added that they will be presenting the monthly appropriations and fund reports electronically now. John thanked everyone for working with the budget. The next budget meeting will be held July 22 at 2:30 pm in the EOC.
