APPROPRIATION TRANSFER: The Commissioners received an Appropriation Transfer from the Coroner requesting \$480 to be transferred from Lab & Morgue to Travel in order to attend the annual Coroners Conference. Greg made note that the Coroner's Lab & Morgue line has been half used up already and most of his other line items are used up as well. He continued to say that the Commissioners do not have to approve any transfers that are requested. He said that maybe at the next budget meeting they should remind the department heads to make sure they have the funds before they schedule to travel.

EMS SQUADS TO SELL: EMS Chief Steve Brown is interested in selling 2 older squads. The Commissioners received some requests from Volunteer Fire Departments in the county, asking for the squads. Greg said he would look into what needs to be done to sell the vehicles.

SEWER-GOOD HOPE TOWNSHIP: The Commissioners spoke with Sewer Systems Manager Kevin Loudin about a request from Good Hope Township to acquire another tap to add a facility for their township workers to clean up. The Commissioners asked Kevin to check and see if they can tie into the existing tap. Kevin said he would check.

SEWER-ROCKBRIDGE FLEA MARKET: The Commissioners discussed the Flea Market in Rockbridge with Sewer Systems Manager Kevin Loudin. They have had requests from tenants who do not want sewer service. According to policy, the tenants can remove the fixtures and defer payment for a year, and after the year have the option to reconnect. If they choose not to reconnect at that time, a new tap fee will be charged when they do decide. Kevin said he would speak with Roger Shaw and explain it to him.

<u>SANDY WINTERMUTE-911 DIRECTOR:</u> 911 Director Sandy Wintermute addressed the Commissioners about a proposal she received from Rich Warren with Hocking Internet Technologies. She said Rich is upgrading their DSL to High Speed Internet and would like to mount a stick on the tower behind the 911 Center. He said in return, their internet would be free. Greg said he thought the tower belonged to HAM radio. The Commissioners will check to see who the tower belongs to and if they do allow the stick to be mounted on the tower, a contractual agreement will need to be drawn up.

PERFECTION GROUP: The Perfection Group presented more information to the Commissioners about how to save on energy costs and do some upgrades to the county buildings. The Commissioners do not feel comfortable at this time to continue with the process and asked them to contact the office in August or September when they have a better idea on the budget projections for the remainder of the year and into 2011.

AUDITOR KEN WILSON-REGIONAL JAIL: Auditor Ken Wilson spoke to the Commissioners about the General Fund Budget in conjunction with the Regional Jail.
