**HAYDENVILLE RESIDENT PATTY HORN:** Haydenville resident Patty Horn updated the Commissioners on the Haydenville tornado siren and said that it did not go off during the test on Wednesday. She said she spoke with Sandy Johnson with HAPCAP and also Sandy Wintermute with 911 and they are working on gathering information on the siren.

Green Township Trustee John Fuller told the Commissioners he was told the siren was struck by lightning and he wanted to verify that it was up to the trustees to maintain and repair the siren when needed. The Commissioners confirmed that it was the trustees responsibility. Sandy said she would get in touch with Susan Rauber and would then give an update.

**FOR THE RECORD:** Sandy asked that a sign be put on the door to turn all cell phones on vibrate during the meetings.

SOLID WASTE GENERATION FEE DISCUSSION: The Commissioners discussed the Solid Waste Generation fee and if they needed to vote on it. They thought they didn't need to vote because the City of Logan voted against it. Greg confirmed with Roger Bail that the issue is dead due to the no vote by the City of Logan. Sandy did say that she was opposed to it and feels that the money has not been handled properly. Greg said that he looked into separating from the district and found out that that would only cost them more money because the county does not have a landfill, so then they would be charged generation fees to which ever landfill they used. John feels that the generation fee was the most sensible thing to do. Sandy added that she doesn't feel that they should be picking up trash and that when a cost is added, she has never seen it removed.
