John said they only requested a 15% cut and he was not sure how it got cut that much. Dr. Cummin brought up the Sheriff's cruisers that were recently approved to be purchased and then continued to speak about the amount of vehicles that the Sheriff has and also brought up the they gave EMA \$5,000. He continued to explain how he pays some of his county phone bills from his own pocket because he uses it for personal calls. Greg said that he needs to come to the budget meeting next week. John said he needs to submit to them how much he needs to finish out the year.
