RECONVENE: The meeting reconvened at 2:30 pm in the Emergency Operations Center with General Fund department heads present.

GENERAL FUND BUDGET MEETING: Greg thanked everyone for their efforts and said that the general fund is on track because everyone is watching their spending. Ken spoke about the budget and said revenue is up about 5% and if the trend continues, we will not be in the red as much as previously projected. He said it will be very difficult to know how the state budget will effect the county's budget. The Commissioner requested that the budget worksheets for 2011 be distributed in October so they will have a better idea of projected revenue. Greg concluded by saying that he understands that some departments have some line items have been depleted but services have to be provided.

BWC CHARGEBACK MEETING: The Commissioners explained to County Department heads that they plan on changing the way the Workers Comp rates are figured. Currently the rate is based on payroll 100%, but the Commissioners would like to move to 50% payroll, 50% claims for 2011 and then in 2012 move to 100% claims. A cover letter stating the rate that each department will use to figure workers comp will be attached to their budget worksheets. Safety Coordinator Marjorie Davis said that department heads need to stress safety to their employees because every claim impacts the county. Engineer Bill Shaw asked the Commissioners if this would be a permanent procedure or if it will change to benefit the General Fund. The Commissioners said this will be the procedure now on.
