MEETING: The meeting was called to order by President Greg Green.

MINUTES: Motion by John Walker and seconded by Sandy Ogle to accept the minutes.

Discussion:

Sandy said the minutes were correct, but in reference to the motion to change the Workers Comp billing, she said that all departments in the general fund need to be responsible for Workers Comp. She thought that was how the motion was. John said that his intention, when he made the motion, for it to be billed based on the last breakdown the Auditor's office sent down, which was broken up based on funds. He said he feels the outside agencies should pay because they have levies. Greg feels the county should help each other out and suggested lengthening the time to go to 100% claims. He said he thinks the original motion was too vague and needs to be clarified, and should be in Resolution form. John said the idea was to help the General fund. Greg said it then should also be about helping each department, and if one office in the General fund has a claim, then that office should pay for it, it would be uniform across the Board. Sandy feels it is only fair to have all the departments be responsible for paying based on their claims.

<u>MAXIMUS AGREEMENT:</u> Motion by John Walker and seconded by Sandy Ogle to sign the Agreement to provide Professional Consulting Services with Maximus to assist in the indirect cost allocation plans for 2010, 2011 and 2012. Vote: Walker, yea, Ogle, yea, Green, yea.

PURCHASE OF SERVICE CONTRACT-J&FS AND PICKAWAY COUNTY EDUCATIONAL SERVICE

SEWER DEPARTMENT-CONTRACT SERVICES LOW: The Commissioners discussed the Sewer Fund and that the Contract Services line item is nearly depleted. Greg suggested to cut back on the use of sewer consultant John Perry and also Engineering Firm Sands Decker. John mentioned that repairs need to be done at Rockbridge and Haydenville, but feels Haydenville needs to be done first.

MAINTENANCE SUPERVISOR OFFICE SPACE: The Commissioners discussed the possibility of moving the Maintenance Supervisor's office to the Keynes Garage. The Commissioners said they need to speak with the Auditor about his things that are stored in that area. Greg said there is a possibility that the county could received funds for rent if the current maintenance office is vacated, or maybe even use it for the Auditor's to use during the county audit each year.
