## **COMMISSIONERS MEETING AUGUST 31, 2010**

The Board of Hocking County Commissioners met in regular session this 31<sup>st</sup> day of August 2010 with the following members present John Walker and Sandy Ogle. Greg Green was excused to attend another meeting.

**MEETING:** The meeting was called to order by Vice President Sandy Ogle.

**MINUTES:** Motion by John Walker and seconded by Sandy Ogle to accept minutes. Vote: Walker, yea, Ogle, yea.

**THELMA AND KEVIN FARMER:** Thelma Farmer spoke to the Commissioners about the generation fee that the Solid Waste District is considering putting on again. She said she feels that they should cut their expenditures to run more efficiently, like many other agencies are doing, so the generation fee wouldn't be needed. Sandy said she agrees with Thelma that the Solid Waste District needs to run more efficiently and that there will be some changes. Bill Kaeppner explained that the generation fee is permissive, so it will only be used if needed. He continue to say that they need to get everything under control and have a the tools in place so the EPA doesn't take over. Kevin Farmer said the Solid Waste District will not pick up recyclables unless the pick up trash, saying they need the trash revenue in order to operate the recycling. He feels the figures the Solid Waste District is giving should be separate. Kevin said they would like to see them work with the private haulers to help. He said that if the generation fee is not put on, they can help make it cheaper to do recycling. John said he believes the generation fee is necessary so they can get things straightened out.

BOARD OF ELECTIONS-REQUEST FOR ADDITIONAL FUNDS: The Commissioners received a letter from the Board of Elections requesting an additional \$25,879.18 to cover expenses for the November 2, 2010 General Election. The Commissioners said they will discuss it later after they look into it.
