The Board of Hocking County Commissioners met in regular session this 28th day of September 2010 with the following members present John Walker, Sandy Ogle, and Greg Green.

MEETING: The meeting was called to order by President Greg Green.

MINUTES: Motion by Sandy Ogle and seconded by John Walker to accept the minutes. Vote: Walker, yea, Ogle, yea, Green, yea.

FLOODPLAIN MANAGEMENT REGULATIONS PUBLIC HEARING: A Public Hearing was held at 10:00 am for the adoption of Floodplain Management Regulations. CLEANING SUPERVISOR AND ASSISTANT: Cleaning Supervisor Nancy Powers and Cleaning and Maintenance Assistant Ed Manley were called before the Board to discuss schedule changes for both employees. The Commissioners also clarified that when Nancy or Maintenance Supervisor Chris Gompf takes time off, Ed needs to provide coverage for them.

DRUG TESTING DISCUSSION: Sandy asked if the county could randomly drug test employees. John and Greg said they wanted to do that a couple of years ago, but are not able to. An employee can be testing upon hiring and if there is an accident, but cannot be randomly drug tested.
