BILL KAEPPNER-SOLID WASTE BOARD MEMBER: Solid Waste Board Member Bill Kaeppner noted that The Columbus Dispatch had an article in the paper this morning reporting SWACO approved a \$3 per ton increase for 2011 and another \$3 a ton increase for 2012.

KEN WILSON-BROADBAND COMMITTEE RFP RECOMMENDATION: Ken Wilson spoke on behalf of the Broadband Committee with the recommendation concerning the RFP submitted by Rich Warren of Hocking Internet Technologies. Ken explained to the Commissioners that the committee is concerned with the long term contractual agreement that was proposed, financial obligations and the affects of this on other service providers. The committee is also looking forward to some new technology that may be able to better serve the county due to the way it travels over the hills and through trees. For these reason, the committee recommends that the Commissioners reject the bid from Hocking Internet Technologies.

REJECT BROADBAND PROPOSAL-HOCKING INTERNET TECHNOLOGIES: Motion by John Walker and seconded by Sandy Ogle to reject the broadband proposal submitted by Rich Warren of Hocking Internet Technologies, upon the recommendation of the Hocking County Broadband Committee.

Greg commended Rich Warren for submitting the only proposal and for his initiative to bring Broadband through the County. He continued to say that it will be best to wait to see what the new technologies are and go from there.

The Commissioners instructed him to inquire about CDBG funding, but clarified that if they received CDBG funding for a siren, that the siren is their responsibility. They also said they would check to see if there would be any other agencies that may have funds for that type of purchase. Greg suggested that the residents also consider purchasing a weather radio.
