**ROGER SHAW:** Local Businessman Roger Shaw spoke to the Commissioners about the tap fees that were quoted to him for various projects at the Hocking Hills Market in Rockbridge. He said the cost is too much considering all of the business options will not be businesses that will be open everyday for 8 hours a day. The business will be mostly weekends, for a few months out of the year. One business would only be open for a few hours a day.
