Ms. Moder commented volunteer waivers are on the 28th page of Anna's proposal. She asked if the waiver had been drafted. Commissioner Dickerson said no but he would give it to the prosecuting attorney.

Commissioner Dickerson commented they passed a motion that they are seeking estimates and quotes on things they have talked about. Brian Wyskiver will oversee the project.

Ms. Moder asked for clarification on the statement by Mr. Dickerson that "someone used a derogatory term towards one of the commissioners over social media" was not Ms. Moder. Commissioner Dickerson said the statement of name calling was not by Belinda Moder.
