

COMMISSIONERS MEETING MAY 28, 2019

The Board of Hocking County Commissioners met in regular session this 28th day of May 2019 with the following members present: Sandra Ogle and Jeff Dickerson. Gary Waugh excused

MEETING: The meeting was called to order by President Ogle.

MINUTES: Commissioner Ogle postponed the reading of the minutes.

AGENDA: Motion by Jeff Dickerson and seconded by Sandra Ogle to approve agenda.

Vote: Ogle, yea, Dickerson, yea.

JOYCE SHRINER:

Joyce Shriner introduced Shannon Carter the new area leader for OSU Extension. Ms. Shriner requested permission for Shannon to fill Joyce's position. Shannon will be in charge of hiring the 4-H Educator for Hocking County. Motion by Jeff Dickerson and seconded by Sandra Ogle to approve.

Ms. Shriner has been covering the Master Gardner Volunteer Program and the Ohio Certified Volunteer Program. She said it is unreasonable for the new 4-H Educator to continue to supervise those two volunteer programs. She requested a stipend to pay one of the educators in a neighboring county to supervise those programs. Commissioner Ogle said they would have to take that into consideration.

Her last request was for a new copier; she presented several quotes. Commissioner Ogle said they will let her know next week.

William Kaepfner asked how many copies they make per month.

JILL SQUIRES:

Jill Squires discussed the Old Green School, which is in the commissioner's name but purchased and maintained by the County DD.

Commissioner Dickerson said he has been contacted by an individual who is interested in the property. Ms. Squires discussed the intentions of the individual. If the intended use is for development disabilities the board would not have to pay back the Capital Community Assistance funds.

Ms. Squires gave a presentation of the Hocking County Board of DD budget including cost of services and staff, their total budget for 2020, services and staff costs that would be reduced, and possible solutions.

Ms. Squires said their intentions are to put another levy on the ballot.
