

COMMISSIONERS MEETING JULY 30, 2019

The Board of Hocking County Commissioners met in regular session this 30th day of July 2019 with the following members present: Sandra Ogle and Gary Waugh. Jeff Dickerson excused.

MEETING: The meeting was called to order by President Ogle.

MINUTES: Motion by Gary Waugh and seconded by Sandra Ogle to approve.

Commissioner Ogle read a letter from Judge John Wallace that he will have the option of continuing to use the APA or run his own probation department. The state will give Judge Wallace \$160,000.00 per year to staff and equip his own department.

Commissioner Ogle said this is just a letter for information purposes.

Sue Morgan asked if it would ease the money problem if he did it on his own. Commissioner Ogle said it wouldn't make any difference, they can do what they want.
