Ms. Brown said she was there on behalf of her foundation, Hope Blooms. She would like to apply for the Clean Ohio Grant and requested a letter of support from the commissioners for the grant.

CERTIFICATE OF ESTIMATED PROPERTY TAX REVENUE:

Commissioner Ogle presented the Certificate of Estimated Property Tax Revenue for one and one half mills additional levy. This would generate \$992,384.00. Motion by Sandra Ogle and seconded by Jeff Dickerson to accept estimation.

RESOLUTION TO PROCEED OF THE TAXING AUTHORITY:

Commissioner Ogle presented the Resolution to Proceed of the Taxing Authority. The current tax valuation of the Hocking County is \$661,589,940.00, to generate a revenue amount of \$992,384.00, for a levy amount of 1.5 mills for the purpose of community development disabilities programs and services pursuant to Chapter 5126 of the Revised Code.

Motion by Gary Waugh and seconded by Jeff Dickerson to approve.

Discussion: Commissioner Dickerson asked for clarity on the revenue that would be generated.

Commissioner Ogle said she has looked at the budget and at the present DD receives 3.02 Mills. The tax levies revenue projected for 2020 is \$2,004,099.00. The total revenue projected for 2020 is \$2,736,368.00 and that serves 250 people. Jill Squires said it is 265 people.

Commissioner Ogle said if a 1.5 mill levy was put on the ballot that would generate new money \$992,384.00. Commissioner Ogle said we sitting at this desk is just as desperate for money as what DD is. She feels we all have to learn to work within our budget.

Commissioner Ogle said there are people down at the senior center who have to make the decision between buying medication, paying taxes, and buying food. It is a putting a lot of stress and extra hurt on people to have to come up with an extra million dollars in taxes. She does not feel we can put the stress on the people of Hocking County to come up with a million dollars. She understands and can see where money is being cut from the state; however a mill and a half is a lot to ask for at one time.

Commissioner Waugh said it is hard for us to address something like this because we are being forced basically to count paper clips. He is sympathetic but he can't justify that when the county is dealing with 29,000 trying to work within our budget. Commissioner Waugh commented he is sympathetic to the people but he is not sympathetic towards the issue.

Jill Squires asked if there is another amount the commissioners would be more comfortable with to put on the ballot because they project deficit spending by the end of 2020. When the county Board of DD no longer functions it falls to the commissioners.

Commissioner Ogle said she does not see how the taxpayers can come up with the money.

Ms. Squires said they did not ask for a replacement levy. She explained how there would be a 12% increase if they replace their current levies.

Commissioner Ogle asked how many programs they have that are not mandated. Jill said the pooled cluster funding.

Jill said the state is not handing out anymore waivers but that she did obtain ten waivers in the last six months. Jill said their employees are the biggest asset, she cannot hire a high school student. They people with disabilities are sometimes so severe this is their everyday life.

Commissioner Ogle said the tax payers don't have the money, it's as simple as that.

Jill said make it a shorter term levy because they aren't going to survive after next year if they don't have the funding.

Commissioner Waugh said it sounds like we are cold-hearted but their responsibility is to the county and they hear all the time people can't afford their taxes. He is sympathetic to both issues.

Karon Fisher said the last time they were on the ballot was 2009 and they have stretched that ten years so they wouldn't have to go back to the ballot. Now, they have no other choice and maybe if they let the voters decide they might be able to stretch it out another ten years.

Commissioner Ogle said she is very sorry but she does not want to put more stress on the people of Hocking County.

Karon said we realize that but they would at least like to give the voters a chance to vote yes or no.

Jim Kalklosch asked if when they default it falls back on the commissioners.

The commissioners and Ms. Squires discussed the possibility have a replacement levy to go on the ballot March 2020.

Roll Call Vote: Ogle, nay, Dickerson, nay, Waugh, nay.

Jill requested a replacement for all three levies for the November ballot with collection January 1, 2020.

Commissioner Ogle said it would have to wait until the March ballot.
