GENERAL BUSINESS:

Commissioner Ogle commented the Fall Recycle Day is October 12th from 9:00-1:00pm on Sutton Road.

There is a Public Meeting on October 9th at 6:30PM at the Logan High School regarding the Bradford Drive Sewer.

DISCUSSION ON PUBLIC DEFENDER:

Ken Wilson begin the discussion on the Public Defender changes in state biennial budget. CCAO Representative John Leutz said the primary issue to increase reimburse for indigent defense on behalf of the county. Indigent defense is the constitutional obligation of the state, which has been assigned to the counties to perform for them. The important thing about this is there is a finite amount of money, which consist of two pots. Regardless of costs for the fiscal year July 1 – June 30, that money that has been appropriated is allocated on an equal percentage to each county as their share of funding available for reimbursement of costs that they expended on indigent defense representation during that fiscal year.

Ken Wilson asked if the money is spent prior to June 30th would the state appropriate additional monies. Mr. Leutz said no it is fixed. The Public Defender will change the reimbursement during the fiscal year.

Will Kernen on behalf of the Hocking County Bar Association asked what the total reimbursement for the last fiscal year. Mr. Leutz said about 50 million total. Mr. Kernen asked if the total funds available have more than doubled. Mr. Leutz said yes but that doesn't have any relationship to expenditures. That appropriation was designed to provide additional reimbursement to counties.

Ben Fickel commented when they started discussion if the money is appropriated all counties will jump ship and raise rates. The Public Defender's released a recommendation for counties to do that. If they are anticipating all counties raising rates to \$75 then it is only logical to think all counties will raise rates leaving reimbursement at 70%.

Jim Kalklosch asked if all counties draw from the indigent funds. Mr. Leutz said yes.

John Honeck commented the system as a whole is underfunded. Each Board of Commissioner has to come up with rates to pay attorneys based on their budget.

Motion by Jeff Dickerson and seconded by Gary Waugh to return to General Business at 10:24 AM.
