

## COMMISSIONERS MEETING MAY 26, 2020

The Board of Hocking County Commissioners met in regular session this 26<sup>th</sup> day of May 2020 with the following members present: Sandra Ogle, Jeff Dickerson, and Gary Waugh.

**MEETING:** The meeting was called to order by President Gary Waugh.

**MINUTES:** Approval of minutes later on during meeting.

**AGENDA:** Motion by Jeff Dickerson and seconded by Sandra Ogle to approve agenda.

### **CESALIE GUSTAFSON:**

Cesalie Gustafson, Director of EMA, presented the Commissioners with her research findings for additional funding. FEMA is still trying to sort out what will be covered and what will not. Cesalie told the Commissioners she could have something ready and prepared in case FEMA decides to allow protective measures to be covered. Commissioner Waugh added that when the courthouse does open, most if not all elected officials will require a face mask, and the courthouse, may require a face mask to enter. Waugh asked if this does happen, will we have enough masks in supply? Cesalie replied that EMA could supply some masks, with limitation on supplies from the State for certain tiers coming first. Cesalie recommended a sign in sheet when the public enters the courthouse, for tracking purposes. She suggests we keep track of all our supply rate of use, so we may know how much of one product we will need. This is important for FEMA as well. Cesalie asked if the Commissioners see mandatory masks becoming policy. Commissioner Waugh replied yes, with added pressure from elected officials. Commissioner Ogle asked Cesalie if she could help out the Recorder, Sandy Hunt, she is in great need of spray Lysol and wipes. Cesalie replied that she could call Walmart and discuss stock with a manager.

Commissioner Ogle said that once the budget numbers are in, all departments will be cut a certain percentage from their budget, and it will be the office holders' decision on where to take that cut from.
