Commissioners met with elected officials to discuss COVID.

Commissioner Dickerson then passed the floor to Health Commissioner Doug Fisher.

Health Commissioner Doug Fisher discussed the current state of the County. All decisions are now made at a local level because of Senate bill 22. Fisher then listed current stats for Southeast hospitals for total beds available. Fisher recommends as many layers of precautions as you can apply. Fisher recommends masking up, vaccinating, social distancing, etc.

Commissioner Dickerson checked with departments on their mask supplies and directed them to Mark Stout or Bozz Salizzoni if they were in need.

Treasurer Diane Sargent asked Health Commissioner Doug Fisher about a particular situation of a nurse changing a negative to a positive based on symptoms and a close family member being positive. Doug told Diane he would investigate.

Doug Fisher discussed the differences this variant is showing in spread, and higher mortality rate. They are now seeing deaths in younger people, and a whole house becoming positive after one family member is positive. Before, they could keep the family member isolated and contained and stop the spread.
