Darla Miller discussed no set agenda for this meeting, other than to provide an update on the upcoming construction season.

Shawn Flannery passed the guides out to the Commissioners, and Jamie Hindershot went over those guides.

Upcoming projects include asphalt works on 93 & 664, Chieftain Drive improvements, State Park emergency landslide work, and Hocking Hills resurfacing.

For PY2023 work includes bridge replacements, chip and seal, asphalt overlays, etc.

Commissioner Ogle commented on the very little road closures that will occur during the work, and was impressed with that.

Jamie touched on byparts and infrastructure laws, formulas used to calculate funding, and unfortunately no increase in budget for Hocking County is expected.

Discussion on the 33 & 180 area, that has been a concern for awhile now. The traffic studies are complete, and starting to be analyzed. Looking into a new interchange and some new front roads, a project in the 80 million dollar range. Commissioner Waugh commented on how dangerous that area truly is, discussing a jury trial that took place because of a fatal accident in that area. Waugh asked if safety is taken into consideration when being considered for grants on certain projects, and Darla replied that safety is absolutely considered. Jamie added that there will be public meetings, data will be flushed out soon, and there are some short term solutions being considered. Jamie added that the project to be completed with a, hopefully permanent solution, is still years aways. The increased number of tourists was discussed, and the impact on the traffic study that would make. Commissioner Waugh and Commissioner Ogle discussed letters of support to apply for grants, and the businesses around the area submitting letters of support.

Jim Kalklosch asked, as a resident that lives on Starr Route, is a short term solution like reducing the speed limit a good alternative. Jamie answered that he was not an expert but was told that is not currently an option.
