#### **APPOINTMENTS**

#### ABM

John Ferragonio presented the Commissioners with a slideshow that gave detail into what the new HVAC system would intel, where equipment would be located, and the general operation of the HVAC system and the fire alarm system. Commissioner Ogle asked about a fence that would be around the unit behind the courthouse. Cathy, Engineer for ABM, discussed putting a concrete slab down and the fence would connect to brackets on that slab of concrete, easy for mowing and getting around, and safe and secure. Cathy added that she has been diligently working with the fire marshall and code enforcement to make sure these units are over and above the accepted code, which is current 2017 code. There will be mapping, announcer, and strobe lights for the fire alarm system. In addition to that there will be something at the exits, and fire poles.

John discussed the final steps, which is contract and scope. If everything is finished by next week, then the target date can be locked in. Cathy and Tyler added they know how time sensitive this project is and they are committed to making sure the Courthouse has heat by November. Cathy added that the only stall right now is not being able to hold the fire alarm system equipment, but doesn't think the timeline will be an issue. ABM discussed their training so that the IT Director Mark Stout, and employees know how the system will work. Ogle asked for clarification on the price, reading at \$3,175,000.00 - asking if this includes the fire alarm system. John replied yes. Ogle asked about heat strips, and Cathy and Tyler said they went back to their designers and worked it out so that they are able to avoid that. ABM and Commissioners discussed that when there is a forecasted freezing night - snow storm or freezing temps - that employees need to make sure not to turn their unit off for the weekend and night. This will be critical in the temperature being maintained throughout the whole building. Mark Stout added that we could work with Maintenance to make sure that is a check list item before they turn lights off.

Sue Morgan asked about the life expectancy on the equipment. Cathy replied that the HVAC has a 20-25 year life, with maintenance twice a year, then 20 years easily. Ogle asked if the maintenance can be in house or does ABM do that, and Cathy replied they will train Mark to do that upkeep. Morgan asked about warranties. Tyler replied that parts and unti will come with a 1 year warranty, factory set. The compressor will have a 5 year warranty. ABM will back up their design and workmanship for 100% of the life. Mark Stout added that the system is much more efficient and will be saving the County, and offer a much healthier alternative with the circulating air. Commissioner Ogle added that once the Prosecutor is able to review and approve, then they can sign the presented contract in a meeting. Tyler added that if the Prosecutor has an additional red line just to shoot them over to ABM and their legal team will get on it immediately. Commissioner Ogle will make sure it is a priority.

#### SHSC

Scenic Hill Senior Center Director Marjorie Moore and Maintenance Nathan Nelson presented monthly reports and discussed with the Commissioners the ongoing sewer issues at the Spring Street building. They have hydro jetted the lines, used a camera, and will be replacing the line from the kitchen to the sidewalk of the building with a spray in piping that coats the pipe, and gets hard like PVC piping. Marjorie found this vendor while attending a Better Homes and Garden show. They are located out of Mansfield. Marjorie was impressed that this will cost just under \$20K for the Senior Center, money that she has already put aside in her budget with this anticipated project this year. The City of Lgoan is installing new back flows as of today. The Senior Center will be closed the week of June 19th so that this work can be done. Marjorie discussed some upcoming changes with the Radio Lane facility, with automatic doors being ahead at the front entrance, in addition to the new handicap walkway in front of the Spring Street facility.

Marjorie added that she likes the blue fob access to her facilities, she was able to track 394 seniors who came in during one month. The fobs have allowed her accuracy when tracking her attendance.

Sue Morgan asked if these new pipes were clogged. Do you have to call the company who installed them, or can a local plumber take care of it? Nate Nelson replied that any could work with that, but Nate does have a snake - since these sewer issues have been an ongoing issue a snake was purchased by the Senior Center. Marjorie added that the home was built in 1977, these pipes currently have cast iron original pipes, they don't know too much about it. There are sections that are open and lead to nothing that the Senior Center has connected to. Mrs. Morgan commented that you would think it wouldn't pass inspection for whoever built it after, using the original pipes like that. Marjorie said it has caused her sleepless nights, but there is just too much unknown and it needs fixed now.

#### Engineer

Maggi Berry presented the Commissioners with the request to deny all 3 BIDs due to being over budget price. All BIDS were 200% or more over. Maggi requested the project be revised and the BIDS reopen, and advertise.

#### PUBLIC COMMENT

Commissioner Dickerson congratulated opponent Jessica Dicken on her Republican win for the upcoming election in November. Dickerson also congratulated Jim Kalklosch on the Democrat win. These two will run against each other and replace the seat the Dickerson currently sits in.

Commissioner Dickerson clarified that he has no intention of resigning until his term ends, and will finish out his 6 months for his seat. He added that he made no accusations or allegations or accused anyone of doing such. He repeated how the situation was handled, asking Jessica - fair board secretary - does this include the missing funds, he did not make an allegation. Commissioner Dickerson continued commenting on the local news media coverage being one sided, biased and slandered. He was not asked for an interview, not once. He can provide phone bills to prove he was never asked for an interview.
