Commissioner Ogle stated that the most important thing while trying to implement zoning is education. Commissioner Waugh agreed, adding that zoning is a subject that is quite often misinterpreted. The zoning is unique to the County, made how the County wants. Zoning for Hocking would not be the same as zoning in New York City. It is to help the County not hurt it. Jessica Dicken added that the survey out right now, from Audie Wykle, will really help the County. Commissioner Ogle agreed and said education is key, the survey is a wealth of information.
