DLZ

Gary Silcott presented the Commissioners with the monthly updated on the following sewer projects; Murray City, Caron Hill, Union Furnace, Enterprise/664, Hocking Valley Scenic Trail, West Street, Robackbridge Phase 1, and Haydenville Phase 2.

Commissioner Ogle asked about a conversation Gary discussed when talking about the update for Murray City. The discussion was with the legal council pertaining to amounts for settlements. Silcott discussed with Ogle the scenario of working with money left over, and not with a loan. Commissioner Waugh added that he does not want this going on any further. Ogle asked about money left, and Silcott answered 20k left, and 60k is sitting in contingencies. The Commissioners and Silcott discuss pulling the bond from Xpress Underground Construction.

Nelsonville

Commissioner Ogle discussed a meeting with Scott Frank, Nelsonville City Service Director. Scott was inquiring about annexing the Jail into the city. Commissioner Ogle hesitated because why would the Commissioner want to make their employees have to pay city tax. Chief Moritz asked to speak, adding that he spoke with Chief Bickel who informed him that this is a decision the Commissioners are not able to even decide on yet. The jail is and will continue to be in the State's name until the construction is completed. This will be a long way out. Commissioner Waugh asked about a timeline, and Chief Moritz replied around the end of the year 2023 to the beginning of 2024, subject to change. The Sheriff's office is very pleased with the progress made to date.

Commissioner Ogle stated that when Mr. Frank is to call back, she will tell him that the Commissioners are not interested at this time.
