APPOINTMENTS

EMS

EMS Director Scott Brooker presented the Commissioners with an assessment report for the Old Man's Cave EMS Station Hocking County. BDT Architects & Designers prepared an assessment with studies,

HCEMS calls to the ODNR areas, and a probable cost summary. The structure alone is estimated to cost \$457,634.74. Not included in this price is salaries, vehicles, and the property.

Commissioner Dickerson discussed that he and Scott had had prior conversations about an EMS station located near the caves. Dickerson mentioned Hocking Hills elementary school, and spoke with the superintendent about a location beside the school. Dickerson added the critical timing for EMS response, and having a station close by could help save lives. Deb Tobin from Logan Hocking Times asked about contracted emergency services like first choice, Portsmouth, etc. Private agencies that could help respond. Chief Brooker responded that most of those services are part time and do not respond 100% of the time. Commissioners discussed getting a meeting set up with LHSD Superintendent Monte Bainter to discuss some possibilities, because before applying for any funding the property would have to be established and "shovel ready".

HHTA

HHTA Director Karen Raymore presented the Commissioners with the 2022 Quarter 2 HHTA report. This report included advertising, visitor impacts, campaigning, etc. Commissioners discussed with Raymore the program that Lodging Tax Admin Josh Givens recently purchased to help aid the department in locating lodging businesses. Commissioner Ogle discussed the lodging tax, and what the ORC code says it can be used for. Karen Raymore adds that it can be used for marketing, operating costs of 3 welcome centers, etc. Lindsey Perry asked if Commissioner Ogle said that 5% pays one man's salary, and Commissioner Ogle confirmed. It pays Salary, insurance, software, bills associated with the job, etc. The other 95% is tax revenue and can only be used per ORC like mentioned previously. Lindsey Perry asked for clarification that it must be a large amount then, for the salary to be 5%, and Raymore and Ogle confirmed yes.

Concerned Citizen

Tiffany Micochero presented the Commissioners with concerns surrounding not only her residential area of West Logan, but concerns for the County concerning homeless, addiction, and mental health crisis. Tiffany shared stories of personal experiences as to why she has these concerns. The local homeless shelter located near her residence, in her opinion, seems to be when these problems increased. Commissioner Ogle agreed with Tiffany adding that it is difficult to get a handle on the situation because of no zoning. Commissioner Ogle asked that Chief Leif Bickel would attend so that he could be present to help address her concerns. Chief Bickel asked Tiffany, any anyone else, to please call and notify law when they are witnessing these situations. It helps enforce the ability to help take care of the problem. Bickel added that the camp's evictions are difficult to enforce because deputies will trespass the individuals at that camp, but then will move down the river and other individuals will come into the camp that was just evicted. Commissioner Dickerson added that this has not been a new issue, but it seems to always find its way back. The individuals must want and accept the help, and some do not want that. Commissioners and Bickel discuss some programs that are available, including 317 board meets monthly. The Commissioners invited Tiffany to join a 317 meeting, encouraging her that the board would be interested to hear what she says. Commissioners expressed to Tiffany that they respect her for coming forward and being a voice, but their hands are tied and it makes it difficult to get things done. Tiffany replied that she just wants to have the community back, before it is too late. Lindsey Perry asked about ordinance. Commissioner Ogle replied that the process is in works, the first step was to update the county plan - which has been completed. The next step will include a lot of education to the community. Helping those understand codes and zoning is to help the community, not take away from it.
