### Prosecutor Budget Increase

Sandra Ogle spoke about a budget increase of over \$100,000 in salaries was requested by the Prosecutor. The Prosecutor came over and spoke to Sandra Ogle last Thursday. After the meeting an email was sent from the Prosecutor to Sandra Ogle.

Commissioner Ogle, Thank you for taking the time to meet this morning and for the consideration of the proposed budget request. As well as your attentiveness to our presentation and reasoning. I look forward to your addressing this issue at your next meeting on January 6, 2023 as we discussed. Please find the attached motion that is necessary to file pending the outcome of your meeting as noted. We will be happy to withdraw the motion should the budget request be approved. Happy New Year.

Comment by Sandra Ogle that the Motion had to be filed by Monday and the office was closed on Monday and no meeting until Thursday.

Salary line item was \$208,514 2 years ago under the previous Prosecutor. The requested budget for Salaries in 2023 is \$422,933. An increase of 102.83% in 2 years time. Budget approved by the Commissioners was increased only by 10% for 2023. 2022 Salary was \$325,000 which is a 30.13% increase from 2022. Based on those numbers is why the Commissioners thought that 10% increase was sufficient. Common Pleas has ordered Case Number 23-145001 granting the amount of \$636,810 for the Prosecutor's 2023 budget.

Comment by Sandra Ogle and Gary Waugh that they were disappointed that they were not given the opportunity to present their side of the case.

Motion by Sandra Ogle and seconded by Jessica Dicken to approve to pay.

Deb Tobin - Can the Commissioners talk to the Judge?

Gary Waugh - I don't know, he didn't ask us anything. It does say "The amount is reasonable and necessary to perform the duties of said office of the Prosecuting Attorney.

Deb Tobin - Do you have that money that is going to cover that?

Sandra Ogle - We still have enough carryover to cover the budget.

Donna Gainer - How much are court costs for Express?

Sandra Ogle - Unknown but estimated to cost more than it would be worth to pursue.

Annette Harrison - Is this budget amount only for this year?

Sandra Ogle - No

Angela Ryan - Is there anything that gives justification for the increase in budget?

Jessica Dicken - Prosecutor will be hiring multiple people and bringing a part time civil attorney to full time.

Angela Ryan - Are the salaries public?

Sandra Ogle - Yes, make a public records request with the Auditor's office to get the information.

Sue Morgan - Commented whether the cost is less for the budget increase instead of hiring outside legal help.

Express, did the bond get pulled?

Sandra Ogle - Advised by legal counsel not to pull the bond.
