9:30 - Regional Planner Audie Wykle stated that he has been working with Jada Riley at Buckeye Hills Regional Council on funding of the planning office for work on the proposed zoning ordinance. He is here today asking permission to begin the application process on a grant that is available through housing and urban development, it requires no match, and would be spread out over a 5 year period. The total amount is one million dollars, spread out over five years at two hundred thousand a year. The application process requires that the grant application is posted which Mr. Wykle will do so on the Regional Planner website, it also asks for comment from the community. The grant deadline is October 30th. This grant would help for hiring a consultant, And should zoning get passed, Zoning inspectors, a building permit system, and a code enforcement officer.

Budget

Commissioner Ogle stated that she is working on the budget, when finished it will all go to the Auditor's Office then when we get them back we will go through and set aside 15 minutes for each department to go over changes if needed.

PUBLIC COMMENT

Sue Morgan voiced concerns about zoning, and not having a unified community for zoning. Mrs. Morgan is concerned that if a businessman gets in a Commissioners seat they will put zoning and issues that benefit their businesses above what is best for the County.

Stacy Howell stated that we are not jumping into zoning, it will be on a ballot.

Sue Morgan stated that once we get zoning in, the public will not have input after that, Except to express their opinion to the Commissioners.

Sherry Young stated that she thinks that's a huge blanket statement, saying that any business owner that wants to be a part of the Commissioners and part of the laws are automatically going to not worry about the County. Mrs. Young thinks that there are many business owners that while they run a business still care about and love the County, wouldn't do anything to jeopardize or hurt the County.

Sue Morgan reiterated that their business is going to be their first priority, and Commissioner is going to be a second priority, nobody is going to forfeit their own business.

Commissioner Ogle stated that any decision that she has made sitting in her chair, has been for the people and the County, and takes a slight resentment in Mrs. Morgan saying that she is all for zoning, Commissioner Ogle stated that she is for doing what she feels is best for the County.

Sue Morgan said she appreciates that Commissioner Ogle gives 100 percent and that she does care about our County, but zoning is very divided right now. And she just doesn't like the menu of people next year (running for Commissioner).

Commissioner Ogle said you have to have faith in the people that are sitting in Commissioners chairs that they are going to make the decisions for the County and not for them personally.

Sue Morgan stated that has not always been the case.

Richard Morris asked if there were any updates about the Academy Charter School.

Commissioner D'Onofrio stated that they are on the schedule for next week.

Richard Morris asked what they are specifically requesting from the county?

Commissioner D'Onofrio said that as he understands it they need the County Commissioners approval to move forward with their bond issuance through the State.

Commissioner Ogle stated that it does not make us liable.
