9:30 - HCBDD Superintendent Jill Squires along with lifelong residents Charlie Miller, Stephanie Riggs, and Mathew Stout presented a Proclamation and read by Commissioner D'onofrio Proclaiming March 2024 as Disability Awareness Month. Pictures with the Commissioners were taken.

Jill Squires also announced leap year day, February 29, 2024 to be awareness of rare diseases day.

9:35 - Hocking Hills Tourism Association Director Karen Raymore presented an end of 2023 Tourism Report. Stating that HHTA has cut back on marketing within the Columbus area in the peak season and focusing on Cleveland, Cincinnati, Indianapolis, Pittsburgh and Chicago, and seeing a good response to that, they are staying 4-5 nights. Also Ms. Raymore updated the Commissioners on legislation on the sales tax loophole, which could bring in over 500,000 dollars a year. Updates on Clarity of Place consultants plan survey which will be out in May, Two town hall meetings that were successful, and plan to do yearly, End of year Financials, Ms. Raymore went over how the sales tax is distributed, And a preview of the 2024 Budget.

Commissioner D'Onofrio asked if the reason our lodging tax collections have more than doubled in the past 5 years is because of tourism growth and the fact that we are collecting better? Ms. Raymore stated that Hocking County is the Envy of the State with our Lodging Tax Administrator, As Josh does an amazing job, and has helped other Counties, and a combination of better collection, higher rates and more visitors.

Plus HHTA has signed on with a data mining company and is working with OU to get an intern to help with that to get an idea on how many visitors we get and where they travel around the county.

Commissioner Linton asked how Josh gets paid. Ms Raymore explained that Josh gets paid out of the 5% of the 3% of the sales tax.

Commissioner Linton also asked if the survey that Clarity of Place did included emergency services? Ms. Raymore stated that they did, there were in person meetings at the Theater in November and several people from emergency services were there.

Commissioner Linton asked Ms. Raymore to comment about the shortfall of the ability to provide emergency services and taxes that was raised by Laurelville Fire Chief Buthch Valentine.

Ms. Raymore asked if he had talked with the Townships, The lodging tax the HHTA takes in per O.R.C. cannot go to the fire departments but the townships lodging tax income can be spent on anything the townships decide.

Commissioner Ogle clarified that the County does not keep the 5%. The County holds the money.

Commissioner Linton stated that he was just confirming that Josh's pay doesn't come out of the County General Fund.
