# COMMISSIONERS MEETING

## Solid Waste District Meetings

Commissioner Linton stated that the Solid Waste District is operating at a 200,000.00 deficit per year and a change is needed. Option 1 would be a parcel fee, Option 2 would be an increase in tipping fees and rates which would require 60% vote. If those options fail then Option 3 is the Ohio EPA will step in and set a plan of how to solve the problem.

The 3 Public hearings on Parcel fees: Athens Community Center on June 25, at 6 PM, Nelsonville Public Library on July 2, at 6 PM, and In the Logan at the Youth Center on July 11 at 6 PM. We are required to have a recycling plan.

## PUBLIC COMMENT

Roger Bail, former AHSWD Coordinator discussed how the AHSWD was run and how it evolved to the problem that the AHSWD has now. There was discussion from Sue Morgan, Michael Nihiser, Jim Kalklosch and Roger Bail on different options of how to fund AHSWD recycling. The Commissioners made it known they don't take the responsibility of voting on the people's behalf lightly, and want the input of the Community so their voices are heard before the Commissioners make the decision on which way to vote.

Michael Nihiser asked about the a/c units.

Sue Morgan stated that she is confident that all three Commissioners are working hard and together for the good of the County.

Sue Morgan was asking about the fund transfers, and why would they need to transfer at this point of the year.
