IT Director Mark Stout informed that AT&T increased the phone service for the lift stations greatly, He is recommending a company called Granite that has a one month trial on service for 59.99 a month that will be implemented at the Van Sickle Street location to try it at as that location does not have good service, and will be able to log in to check the status instead of having to drive to the location to check for problems.
