Privatization of Pattor Road Letter

Commissioner Linton read an excerpt from a letter written to the Board:

In the 16 years my wife and I have been traveling this road to access the Hocking Hills KOA Holiday Campground and RV Park, the road has continued to get worse and worse. The road surface is so badly broken down, pot-holed and wavy that one can see by the numerous scars and scrape marks that many, many recreational vehicles have bounced, scraped, and bottomed out while traveling up or down this road. Who knows how much damage and costly repairs are as a result. I strongly encourage your consideration to approve the privatization of Pattor Road.

Commissioner Linton informed he will start a conversation with the Township/ Engineers office regarding Pattor Road.

HVAC

Commissioner Davidson Informed that incorrect information is going around social media about the HVAC system. The Demolition crew removing the old jail is NOT responsible for the HVAC issue. A power surge caused by a truck hitting a pole downtown last week was the cause, not the Good Builder demo crew. Commissioner Linton also stated: "For those that are in the building and are uncomfortable, we apologize and we are doing all that we can do to try to get the provider some equipment so that they can repair it."
