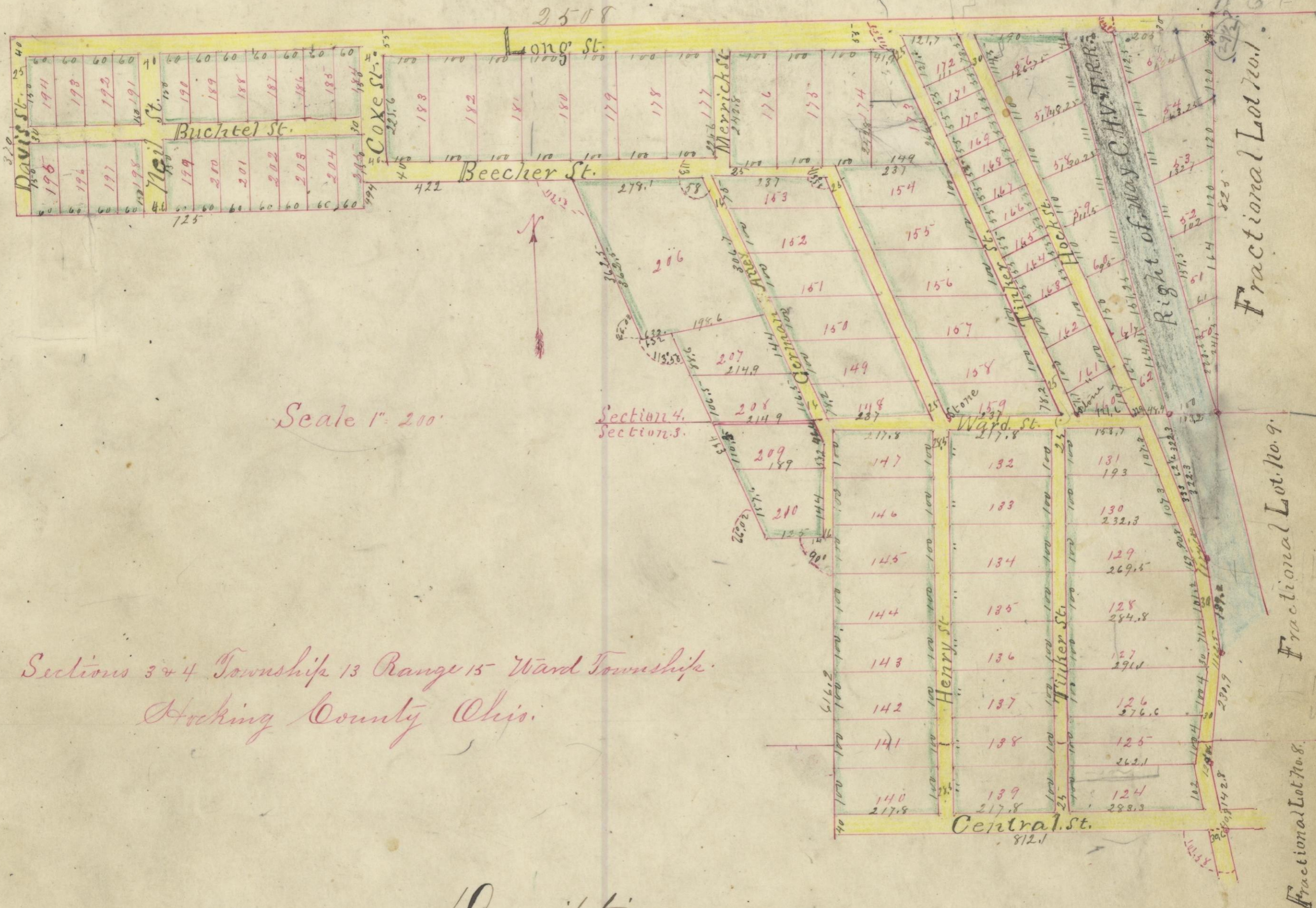


Adams Addition Murray City.

Description.

Being a part of Fractional Lot No. 1 Section 4 and parts of Fractional Lots Nos. 849, Township 13 Range 15 Ohio Company's Purchase Hocking County Ohio.

Beginning at the N.W. corner of Watkins Addition to Murray City from which the N.E. corner of said Fractional Lot No. 1 bears East 52.8 ft; thence West 2508 ft; thence 90° to the left 370 feet thence 90° to the left 725 feet; thence 90° to the left 49.4 feet thence 90° to the right 722 feet thence 60° 02' to the right 362.5 feet thence 66° 02' to the left 632 feet thence 66° 02' to the right 463 feet; thence 66° 02' to the left 141 feet; thence 90° to the right 616.2 feet; thence 90° to the left 872.1 feet; thence 101° 30' to the left 742.8 feet; thence 20° 06' to the right 230.9 feet; thence 17° 03' to the left 189.2 feet; thence 5° 42' to the left 322.3 feet; to the section line; thence 101° 29' to the right 103.2 feet to the S.W. corner of Watkins Addition to Murray City; thence 90° to the left 825 feet to the place of beginning containing Three and eighty five hundredths (3.85) acres. This addition contains 101 Lots, numbered as designated by the plat. The dimensions of lots, Streets and Alleys are marked on the plat in feet and tenths of feet.

A stone is planted on the S.W. corner of lot 159 and one on S.W. corner of lot 160 an iron pin is driven at the N.E. corner of the Addition and at the N.W. corner of intersection of Long Street and the C.H. & T. R.R. Right of way. The right of way of the Columbus Hocking Valley & Toledo Railroad Company is separated from this Addition but designated on the plat.
