

Being parts of Fractional Lots Six (6), Seven (7), and Eight (8), Section Three (3), Township Thirteen (13), Range Fifteen (15),
Hocking County, Ohio.

Beginning at the S.E. corner of Central and Hack Streets in Adams Addition to Murray City; thence West with the
South side of said Central Street 1466 feet to Corporation line; thence South 1880 feet to S.W. corner of Corporation line
thence East 934 feet to the S.W. corner of lot No 107; thence N 22° 30' E 521 feet to the N.W. corner of lot 100; thence S 67° 30' E
17 feet; thence N 22° 30' E 579 feet; thence East 296 feet; thence N 12° 22' E 224 feet; thence N 68° 41' W 130 feet; thence N 33° W 450 feet;
