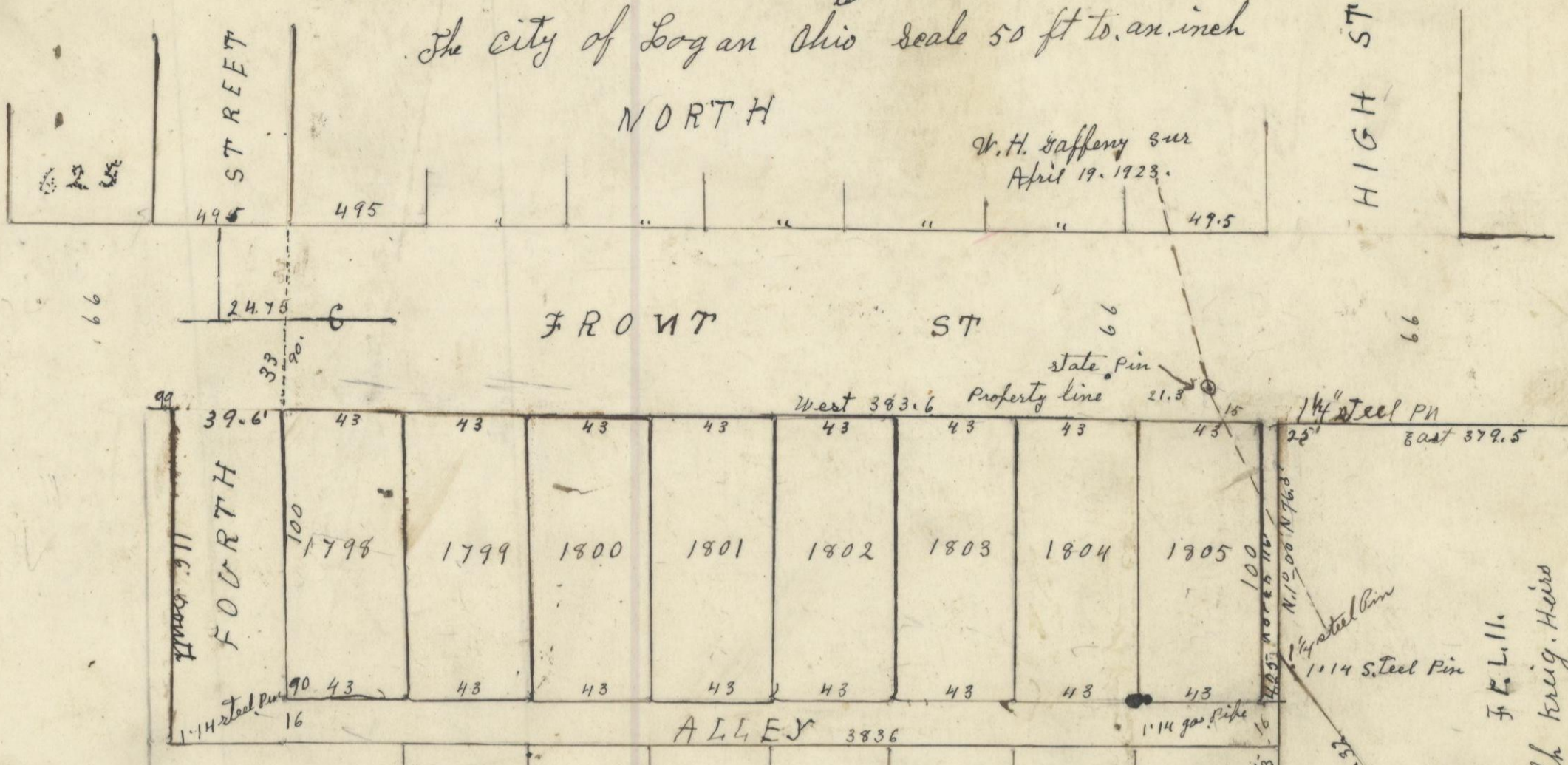


PLAT OF
