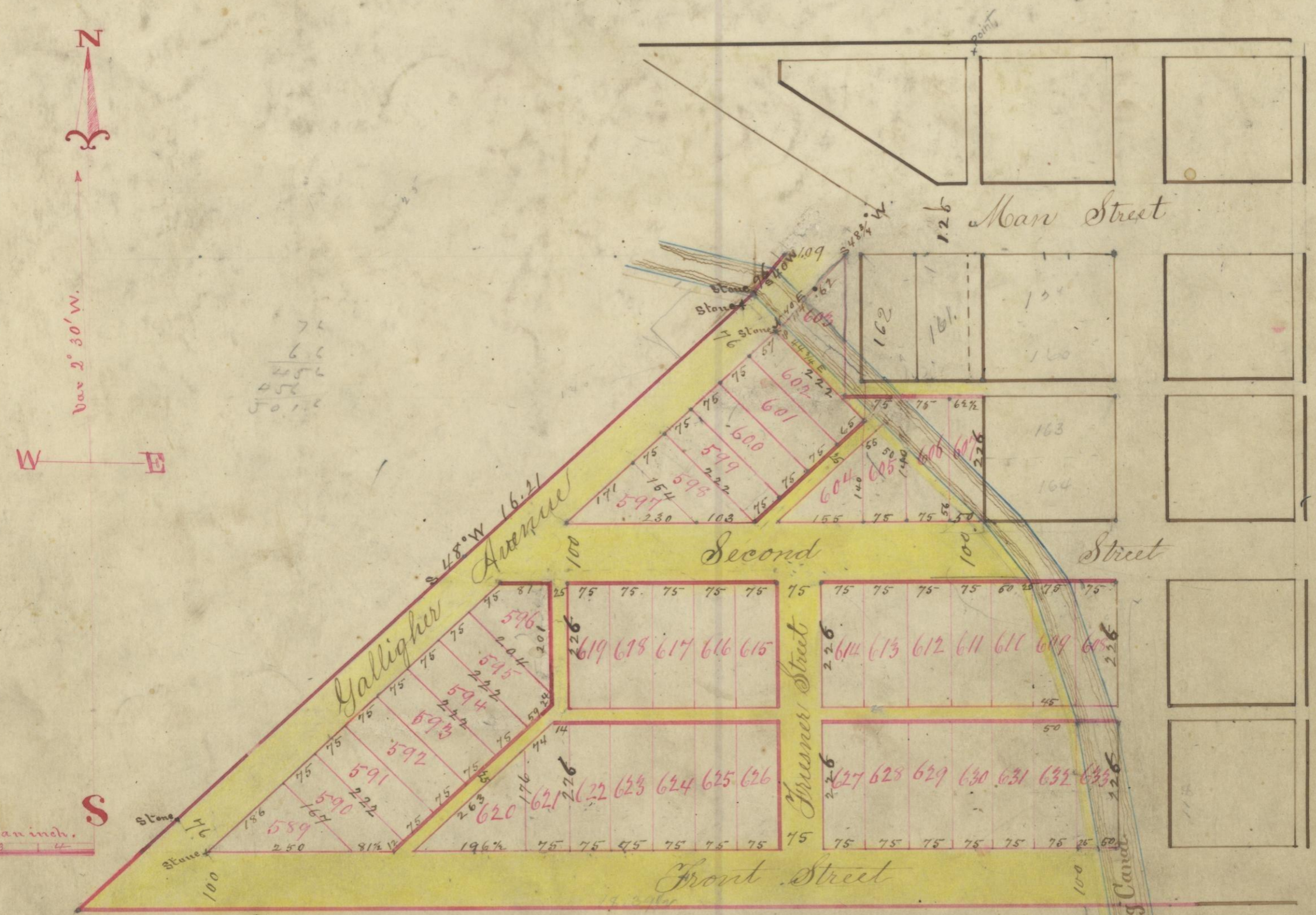


Gallagher and Friesner's Addition TO LOGAN



I hereby certify the foregoing to be a correct plat of Addition to the town of Logan in Falls Township Hocking County Ohio, Beginning 2 1/2 links west of the North west corner of lot No. 162 in Butler and Johnson's addition to Logan, thence West 109 chs., thence S 48° W. 96 chains to a stone in the south bank of the Hocking Canal, thence West 48° West (and passing a stone at 13.87 chains from which the south west corner of Lot 589 in said addition bears S 42° E 58 ft) 16.21 chs., to the southwest corner of said addition, thence East 15.39 1/2 chains to the intersection of the west line of High Street and the south line of Front Street Logan - thence N. 67 1/2° E. to the southeast corner of Lot No. 162, in Butler and Johnson's addition to Logan, thence N. 2.37 1/2, thence N. 2.51 chs. to the southwest corner of Lot No. 160, in said addition thence west 2.25 chs., thence N. 2.26 chs. to beginning containing 12 1/100 acres. Said tract embraces 45 lots numbered from 589 to 633 inclusive. The regular lots front 75 links and extend back at right angles with the streets 225 links and contain 1/100 acres. The dimensions of the fractional lots are written on their respective. Front and second Streets run east and west, Friesner Street North and South, Galligher Avenue from the canal bank runs south 48° W. The alleys are parallel or at right angles with the streets. Said addition containing 12 1/100 acres being a part of the Southeast quarter of Section No. 11, Township 14 Range No. 17 Hocking County Ohio Given under my hand this 19 day of December 1874.
