

Petition for Annexation

To The Commissioners of Hocking County, State of Ohio:

The undersigned, being a majority of the adult freeholders residing on the following described territory situated in the County of Hocking and adjacent to the City of Logan, Ohio; to wit: Being a part of Fractional Lots Nos. 9 and 21 of Section No. 11, 514 N. R. 17 W. Hocking County, Ohio. Beginning at a point on the west boundary line of Cherry Avenue and 273.1 ft. north of the northeast corner of lot no. 974 as now laid, and in the present north corporation line of said city of Logan Ohio: Thence, with said corporation boundary line, S. 88° 47' N. 1270 ft. to a point in the west boundary line of North Wood Street. Thence, with the west line of said Street, N. 0° 04' W. 353.6 ft. Thence with the north boundary line of West Jennison Avenue as shown on the plat herewith attached, N 89° 56' E. 180 ft. to a point in the east line of F. P. Martin lands and in the west line of Glenview Heights Allotment. Thence, with said line, N. 0° 04' W. 615.9 ft. Thence and with the boundary lines of Glenview Heights Allotment, N 89° 56' E. 304.8 ft. Thence S. 37° 21' E. 767 ft. Thence S. 54° 28' E. 215.5 ft. Thence East 148.5 ft. to a point in the west boundary line of Cherry Avenue. Thence with said line S. 0° 43' W. 209.2 ft. to the place of beginning, containing 17 Acres.
