



Plat of Glenview Heights Being a subdivision of Part of Fraction Lot No. 9 of Section No. 11 Twp. No 14 Range No. 17 Hocking County, Ohio. I Certify this is a correct plat of a subdivision of a part of Fraction Lot No. 9 as caused to be laid out by Harry E. Brennan Trustee all dimensions are given in feet units and the courses and numbers are as marked on the plat. That part lying without the Corporation Line of the Village of Logan, Ohio is described as follows, to wit: Beginning at a point in said North Corporation Line where the same intersects the west line of a tract of land conveyed to Harry E. Brennan Trustee by Harriet B. Linton and Husband and Recorded in Deed Book No. 39 Page 423 records of Hocking County, thence with the west line of said Brennan tract N 0° 04' W 965.9 feet to a stake; thence N 89° 56' E 304.8 feet to a stake; thence S 37° 21' E 767.0 feet to a stake; thence S 54° 28' E 215.5 feet to a stake at the Northwest of a one and one half acre tract conveyed to said Harry E. Brennan Trustee in the same Deed before mentioned; thence with the north line of said tract, East 148.5 feet to a point in the west line of Cherry Avenue extended; thence S 0° 43' W with said west line 208.8 feet to a point in the north corporation line of the Village of Logan, Ohio; thence with said corporation line S 88° 47' W 1090 feet to the place of beginning containing 15⁸⁰/₁₀₀ acres.
